Second session Workshop 1 – Prioritising social issues



The event was held online on Thursday 13th March 2025

Within the framework of **Creating Regular Meeting Spaces**, the second session of the workshop was organised, in which the **process of prioritising the issues identified** in the first session was carried out.



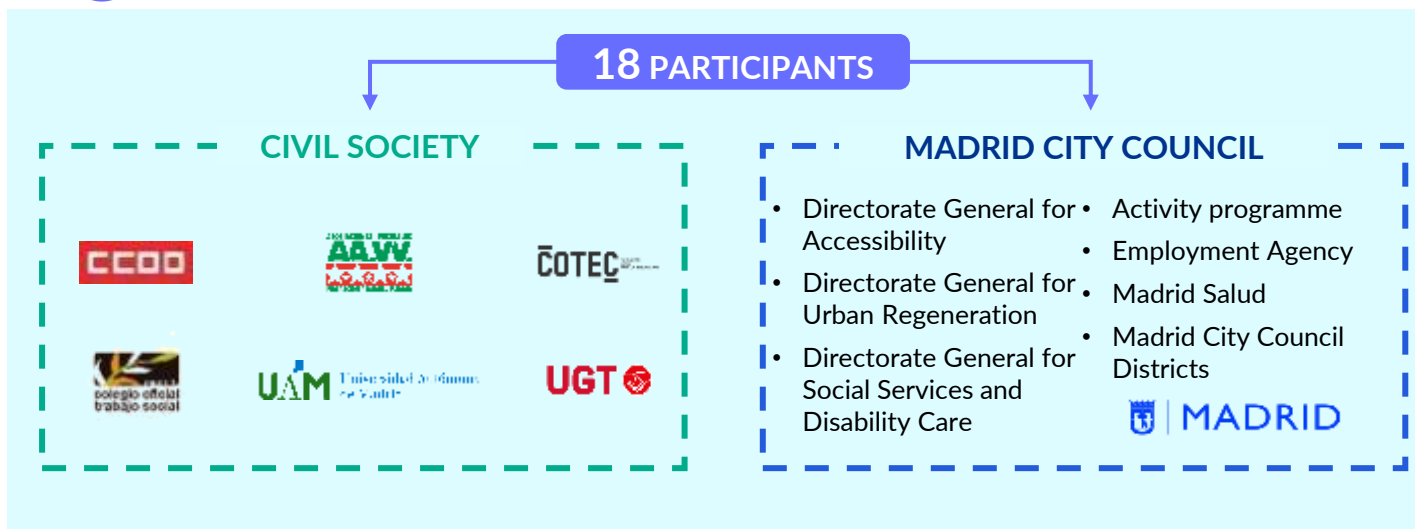
Workshop objective

Prioritise the ten issues identified through two activities: firstly, an overall ranking based on the **relevance perceived** by participants. Secondly, an evaluation based on three key criteria: **impact on citizens, ability of the City Council to intervene and urgency**. Finally, a comparative analysis of the two approaches was conducted to identify patterns and differences.

**Prior to the session, the issues map was updated, adding ICT accessibility. This increased the total number of issues to be prioritised from nine to ten, thus avoiding a category with only one issue.*

Methodology used in the workshops – Design Thinking

Creating Meeting Spaces consists of organising places in which **social issues can be identified** and **innovative solutions can be co-created**. All its sessions are based on the **Design Thinking methodology**, whose principles and stages are detailed below:

First Activity – General Ranking

 18 participants

The **objective** of this dynamic was to rank the issues according to participants' perceptions before applying the criteria:

RANKING GENERAL

RANK THESE ISSUES ACCORDING TO THEIR RELEVANCE.

DESCRIPTION

To start with the dynamics, participants were asked to **rank the ten issues identified according to their perceived relevance** using the Mentimeter tool.

RESULTS



18 responses were received



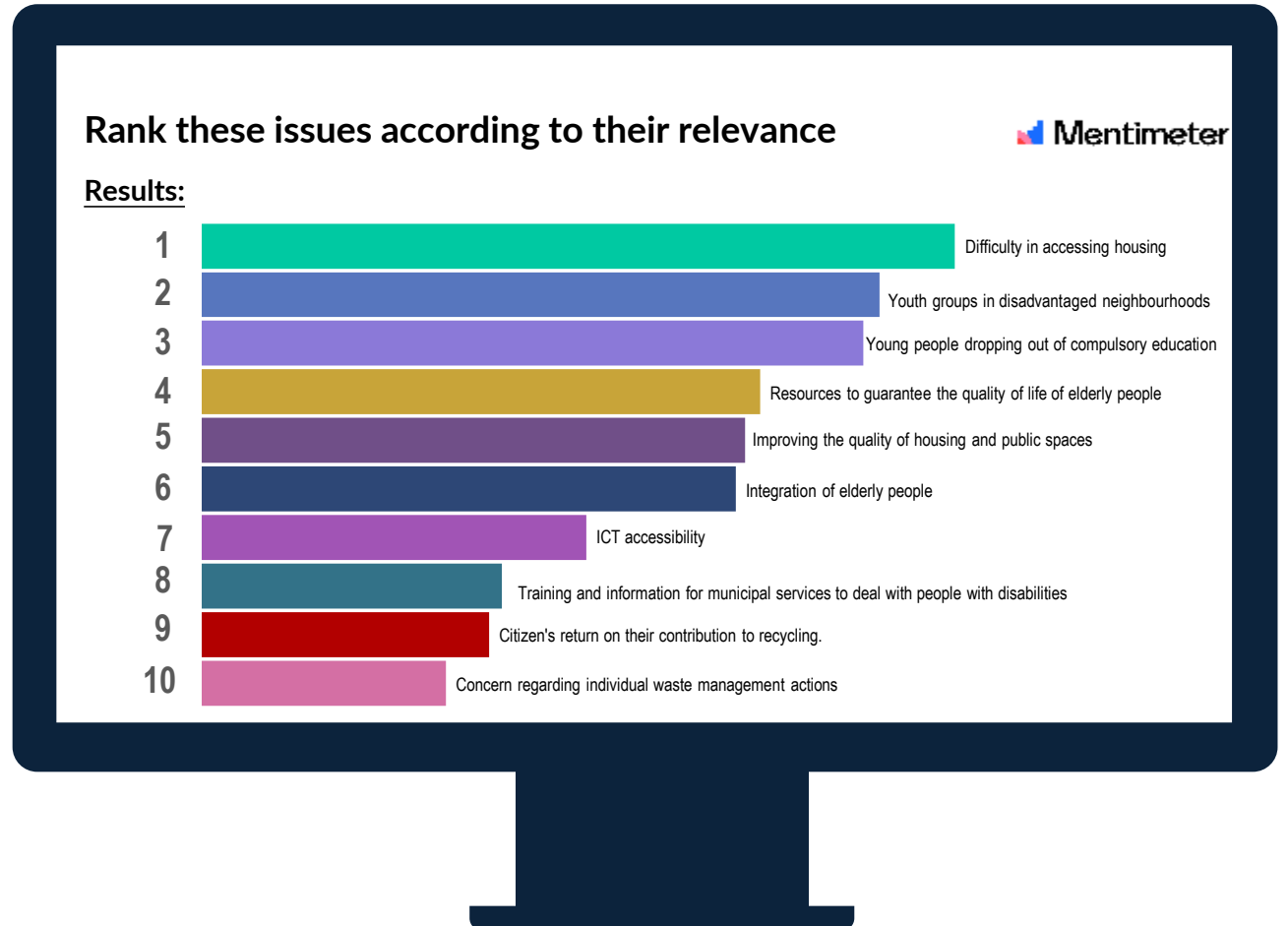
It provided a **general overview** of the **biggest concerns** before introducing more specific criteria for evaluation.



Most prioritised issues:

- **Difficulty in accessing housing**
- **Youth groups in disadvantaged neighbourhoods**
- **Young people dropping out of compulsory education**

Activity 2 – Evaluation by criteria: Impact

The objective of the second activity was to evaluate the 10 issues using the **three pre-established criteria**, thus providing a **more strategic and well-informed vision** for decision-making. The **impact** was evaluated in the first dynamic.

2.1

CRITERIA: IMPACT



RANK THE TEN ISSUES IN ORDER OF IMPACT BASED ON YOUR BEST JUDGEMENT

DESCRIPTION

In this second exercise, a **ranking** was also proposed to prioritise issues, this time evaluating the **impact** criterion, understood as the degree to which the **issue affects citizens' quality of life and well-being**.

RESULTS



The results were **similar to the initial ranking**, suggesting that the group had already understood the impact of each issue from the outset, showing a **natural alignment with the first ranking**.



Most prioritised issues:

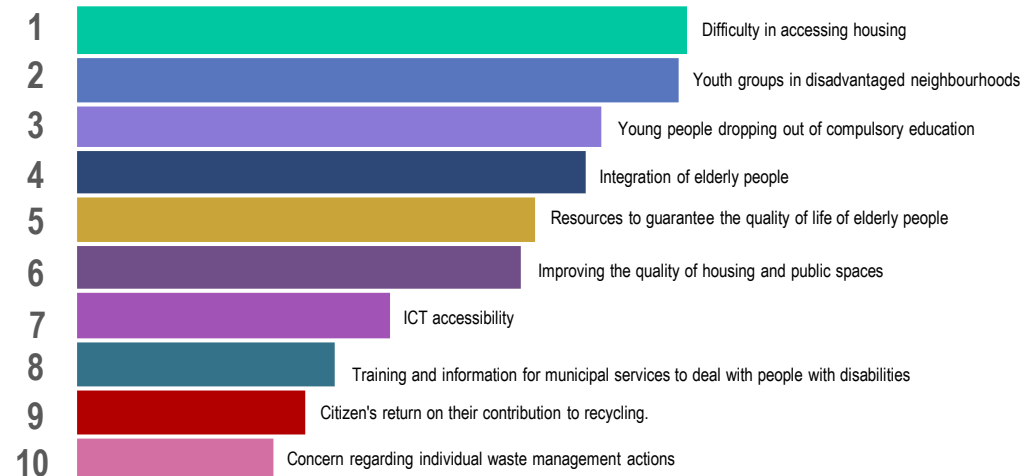
- **Difficulty in accessing housing**
- **Youth groups in disadvantages neighbourhoods**
- **Young people dropping out of compulsory education**

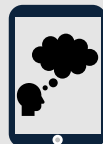


Activity 2 – Evaluation by criteria: Ability to intervene

In the **second part** of activity 2, participants were asked to **distribute 100 points** among the 10 issues according to the **city council's ability to intervene**.

2.2

CRITERIA: CITY COUNCIL'S ABILITY TO INTERVENE



DISTRIBUTE 100 POINTS AMONG THE ISSUES ACCORDING TO THE CITY COUNCIL'S ABILITY TO INTERVENE

DESCRIPTION

Analyse the criteria by distributing **100 points** among the different issues, assigning greater importance to those in which the city council has greater ability, understood as the **ability and competence of the City Council to intervene and offer effective solutions in any given area**.

RESULTS



The variation in the ranking shows that, in some areas, despite their relevance and impact, the **council's ability to intervene is perceived as more limited by participants**.



Most prioritised issues:

- Improving the quality of housing and public spaces
- Youth groups in disadvantaged neighbourhoods
- Integration of elderly people

Activity 2 – Evaluation by criteria: Urgency

In the **third and final exercise** of activity 2, participants were asked to rank the issues facing citizens according to their **urgency**.

2.3

CRITERIA: URGENCY

CHOOSE THE FOUR MOST URGENT ISSUES



DESCRIPTION

Analyse the criteria, identifying the four issues that the City Council considers most urgent to address, considering the urgency in terms of the **priority level for addressing the issue due to the need to be resolved as soon as possible**.

RESULTS



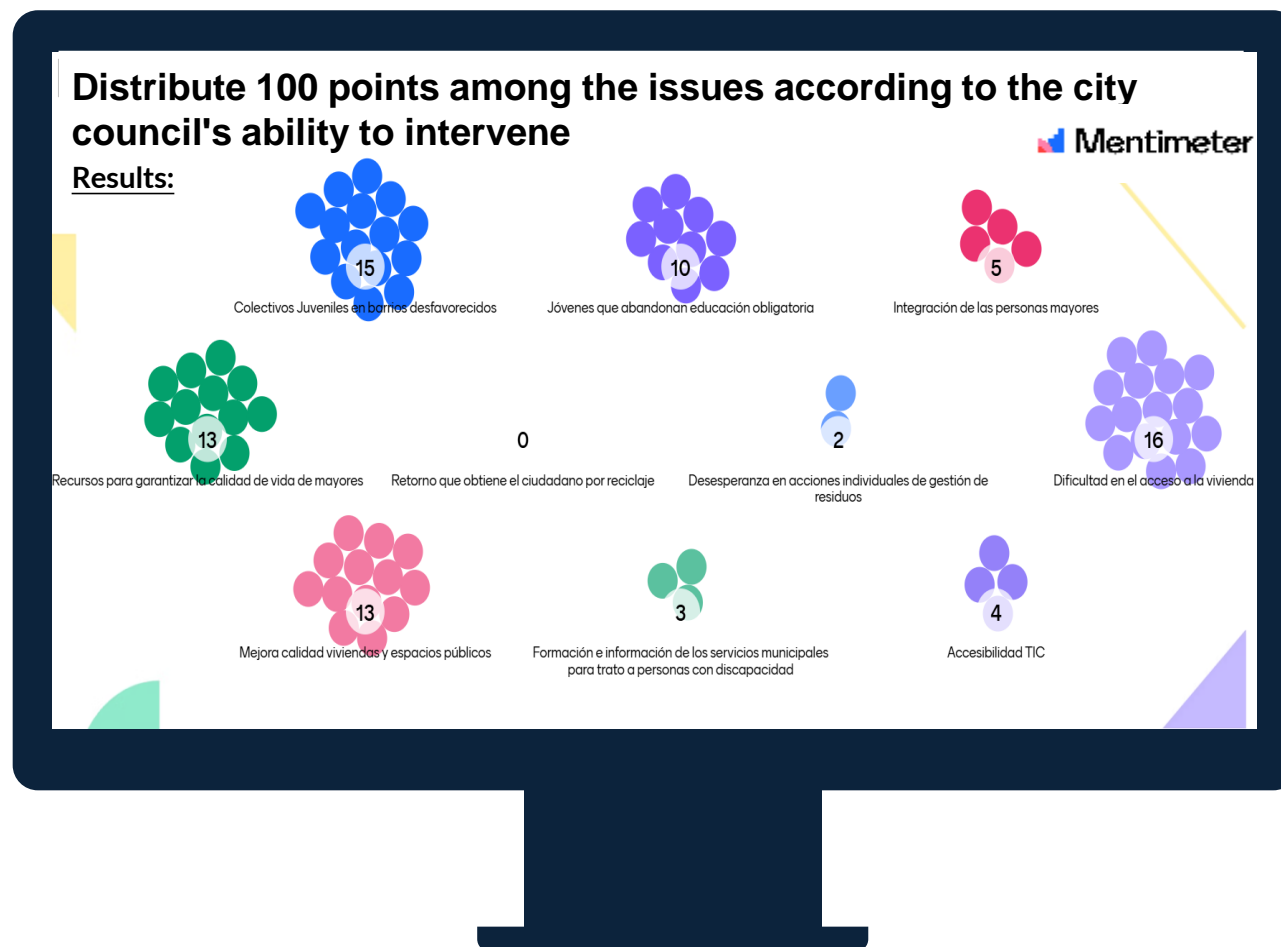
The results are in line with the initial prioritisation, indicating that the issues with the greatest impact **are also perceived as the most urgent**.



Most prioritised issues:

- Difficulty in accessing housing
- Youth groups in disadvantages neighbourhoods
- Improving the quality of housing and public spaces
- Resources to guarantee the quality of life of elderly people

GRAPHICAL REPRESENTATION OF THE RESULTS OF THE SECOND ACTIVITY

DESCRIPTION

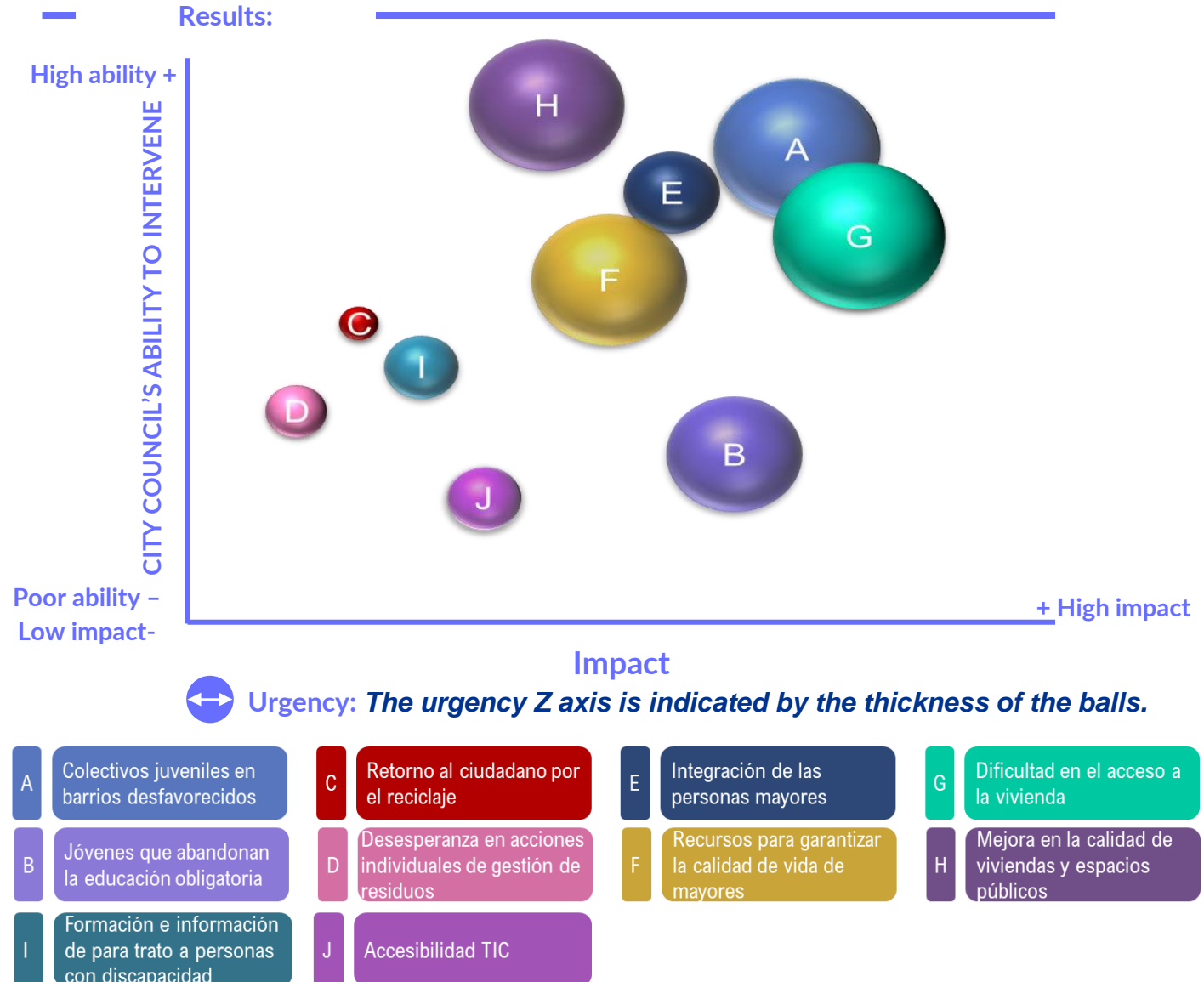
To **conclude the second activity**, a graph was presented that enabled participants to clearly and concisely **visualise the result of the evaluation** carried out using the three criteria: **impact**, the **City Council's ability to intervene**, and **urgency**.

RESULTS



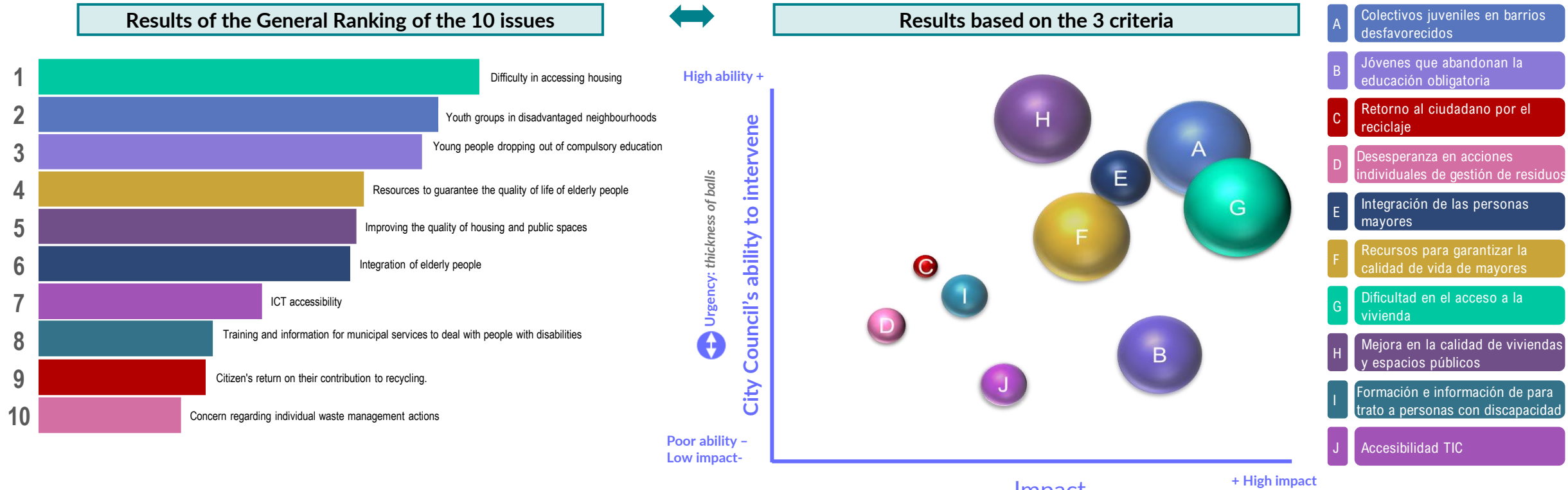
An analysis of the three-axis matrix indicates that certain issues have become more prominent around the three axes. Among these, the following stand out:

- Difficulty in accessing housing
- Youth groups in disadvantages neighbourhoods
- Resources to guarantee the quality of life of elderly people
- Improving the quality of housing and public spaces
- Integration of elderly people



Comparative analysis

Finally, a **comparative analysis** was conducted between the results of **Activity 1**, where prioritisation was based on the participants' initial perceptions, and **Activity 2**, where specific criteria were applied. This exercise enabled the identification of how the **impact**, **ability to act** and **urgency** factors influenced the reordering of the issues.

General conclusions from the session

CONCLUSIONS AFTER COMPARING THE TWO ACTIVITIES



1

Consistency in the issues considered most urgent:

- In both cases, the issues of **difficulties in accessing housing** and **youth groups in disadvantaged neighbourhoods** were identified as the most important by participants.
- This result highlights the **relevance** of these **two issues**, which, **regardless of the approach**, consistently **emerge as priorities**.

2

The issues at the bottom of the rankings are consistent:

- The two issues relating to the category of **waste management**, which were given the lowest priority in the initial ranking, continue to be far from the top positions in subsequent exercises.
- However, it is worth highlighting its **improvement in terms of ability compared** to other issues that were initially given higher priority.

3

Variation according to the city council's ability to intervene

- When considering the city council's ability to intervene, issues such as **improving the quality of housing and public spaces** and the **integration of elderly people** became priorities
- On the other hand, **difficulties in accessing housing and young people dropping out of compulsory education**, despite the high impact and urgency highlighted by participants, fell several places in the ranking in terms of the City Council's ability to intervene.

CONCLUSION



The second session of the first workshop was carried out successfully, meeting the objectives set for the session.

The session also encouraged **active participation** from attendees, who not only organised and evaluated the issues, but also **gave valuable insights** that enriched the session.

In short, this second session has enabled progress to be made in identifying the **issues to be addressed** in future workshops on **co-creating innovative solutions**.
